RE: Distribution of Per Capita Distribution pursuant to Article 4.5 of the Red Pheasant Cree Nation Sovereign Wealth Fund Trust Agreement ("the Trust Agreement")

Distributions to Red Pheasant Minors: (a) Upon receipt of a Council Resolution or other evidence confirming that a Red Pheasant Minor who was alive on the Ratification Date has reached the age of eighteen (18) years old, the Trustee is authorized to pay each Red Pheasant Minor from the Trust Account the sum of fifteen thousand dollars (\$15,000) plus accrued interest of 4% compounded annually from the Compensation Date.
